THE REVISED RATE IS RS.290/- (RUPEES TWO HUNDRED AND NINETY) PER METRIC TONNE. ALL PERSONS DESIRING TO DESPATCH AND TRANSPORT COAL OR OTHERWISE SHALL WITH EFFECT FROM 1ST SEPT.2009, PAY ROYALTY ON COAL AT THE SAID REVISED RATE. THE ADDITIONAL COLLECTION OF CESS ON COAL @ RS. 55/- PER METRIC TONNE, IMPOSED EARLIER VIDE NOTIFICATION NO. MG.115/2007/32 DT 6-01-2009, IS HEREBY WAIVED W.E.F 1ST SEPTEMBER 2009.

ALL COAL MINERS/DEALERS/EXPORTERS ARE DIRECTED TO SURRENDER THEIR UNUSED COAL TRANSPORT CHALLAN ISSUED AT THE OLD RATE AND NEW MINERAL TRANSPORT CHALLAN WILL BE ISSUED FROM THE OFFICES OF THE UNDERSIGNED AT SHILLONG AND ITS DIVISIONAL MINING OFFICES AT JOWAI AND WILLIAMNAGAR.

COAL MINE OWNERS/DEALERS/EXPORTERS SHOULD NOTE THAT NON PAYMENT OF FULL AMOUNT OF ROYALTY ON COAL CONSIGNMENT AT THE REVISED RATE IN ADVANCE FROM 1ST SEPTEMBER 2009 WOULD ENTAIL PAYMENT OF ADDITIONAL ROYALTY AT THE RATE OF RS. 25% OF THE REVISED RATE OF ROYALTY.
