Expression of Interest(EOI)

The Expression of Interest(EOI) are invited for empanelment of any interested Parties/Agencies to assist the Directorate of Mineral Resources in conducting the prospecting operations, preparation/generation of Geological Report for coal. Expression of interest for empaneling any interested Parties/Agencies to assist the Directorate of Mineral Resources in conducting the prospecting operations, preparation/generation of Geological Report for coal.

1. The State Government has notified the OM dated 5th March, 2021 on **Standard Operating Procedure(SOP) for grant of Prospecting License and/or Mining Lease for Coal in the State of Meghalaya.**
2. Under Para 10 of the SOP, **"The State Government, through the Directorate of Mineral resources, may carry out prospecting operation as per the Second proviso to section 4 of the Mines and Minerals (Development and Regulation) Act, 1957 on application being made by the land owners or project proponents, on such terms and conditions as the case may be prescribed by the State Government"**.
3. The EOI is floated to empanel agencies to assist the DMR in conducting prospecting operations, preparation/generation of Geological Report for coal for those applicants/land owners who submits applications to DMR to carry out prospecting operations.
4. The assistance will be required in following aspects: -
 - a) Providing technical persons for drilling of bore holes, samples collection for analysis
 - b) Providing equipment and technical persons required for coal exploration.
 - c) Providing services of qualified person to assist DMR in preparing geological report.
 - d) Any other related works.
5. Interested parties or agency shall quote tentative fee for providing above mentioned services for 100 hectares area of prospecting operation and GR report preparation.

6. Terms and Conditions.

1. The Parties/Agencies must have the experience of at least 2 years in exploration, drilling works and generation of Geological Reports for coal. Certificates issued by competent authority in support to past experience shall be enclosed.
2. The parties/agencies should be duly registered/incorporated under law.
3. The exploration Data and Geological Reports generated and expenditure incurred has to be made available to DMR & Mining and Geology Department both in hard and soft

copies along with maps etc. on such terms and conditions as may be prescribed by the Govt.

4. The parties/agencies should have a capability to carry out exploration on its own or through outside agencies by modern techniques, eg. Remote sensing, detailed Geological resource mapping, Geophysical surveys, drilling, sampling and analysis etc.
5. The Geological Report prepared to be in accordance with Indian Standard procedure for Coal Resource Estimation issued by the Central Geological Programming Boards of Geological Survey of India or any other Standard Procedure specified by the Central Government.
6. The empanelment shall be for a period of 5(five) years initially.
7. The EOI has to be furnished in duplicate copies in a sealed cover to the undersigned on or before **30th March 2021**.
8. **Documents to be furnished along with EOI.**
 - a) Court fee stamp of Rs.50
 - b) Copy of registration/incorporation Certificate of the Company/ Agency.
 - c) Documents to support capability to carry out exploration, drilling and generation of Geological Report either on their own or through outside agency along with projects in hand of last 2(two) years.
 - d) Organizational chart showing their technical capability for Exploration, Drilling and generation of Geological Report and Annual report of the Party/Agency of last financial year.
 - e) Details of technical persons and their qualification and experience.
 - f) Proposed detail exploration work and drilling with the quotation of rates for rendering assistance in terms of manpower and equipment in different proposed prospecting, drilling and generation of Geological Report with timeline.
 - g) PAN/ TAN No.
 - h) GST Registration Certificate.
 - i) Previous Experience document/ certificate.
 - j) Any other documents of relevance.
