PURCHASE OF STORES-GENBERAL TERMS AND CONDITION THEREOF

- 1. Tender from bonafide manufactures of their authorized dealers only will be considered. Manufacturing firms should indicate the registration number of their firms and also mentioned the address of their manufacturing units. Authorised dealers should produce authenticated credentials about their dealership from the principles which they represent.
- 2. Tenders should be properly sealed and the subject matter and last date of submission should be super scribed in bold letter on the body of the cover, bearing the name and address of the tenderer.
- 3. Tenders should reach the office of the Directorate of Mineral Resources, Govt. of Meghalaya, Risa Colony, Shillong 793003 on or before the stipulate date. Late tenders will not be considered.
