1. Meghalaya Environment Protection & Restoration Fund Challan (MEPRF) and Mineral Cess Challan (MCC) have not been issued along with the above Mineral Transport Challan.
2. Mineral Transport Challan (MTC) have been duly stamped "Auctioned Coal" for easy identification at Checkgate.
3. Each truck shall have fluorescent sticker, attach to the windshield which read "Coal sold under Supreme Court Order" and should be properly covered with tarpaulin.
4. Route allotted should be strictly followed.
5. Valid upto 1 (one) month from the date of issue.
6. Covid-19 protocols should be strictly adhered to.
7. The terms and conditions stipulated in the Amended Revised Comprehensive Plan dated 25<sup>th</sup> October, 2022 notified by the Mining & Geology Department, Govt. of Meghalaya should be strictly adhered.
8. The GPS device & RFID tag fitted in the vehicles should be kept active at all times.
