- b) Cost of logging, sampling, analysis and other cost associated (if applicable) will be arrived at after separate negotiation with the empanelled agency.
- c) The empanelled firm/agency shall provide technical assistance, equipment, machineries, manpower and any other support to the DMR for prospecting operation and preparation of Geological Report for coal on payment of approved fee which will be collected from the applicant of prospecting operation.
- d) The prospecting operation shall be undertaken and Geological Report shall be prepared in accordance with Indian Standard Procedure for Coal Resources Estimation issued by the Central Geological Programming Board of Geological Survey of India or any other standard procedure specified by the Central Government in accordance with rule 21 B of the Mineral Concession (Amendment) Rules, 2020.

- e) Agency shall assist the DMR in conducting prospecting operations under the overall supervision of Senior Geologist/Geologist deputed for each application of prospecting operation.
- f) The agency assisting in conducting the prospecting operations shall submit a report of the work done by it during each half of financial year, stating the number of persons and machineries engaged and disclosing the complete geological data, geophysical data and all other information collected during the period to DMR for onward submission to the Central Mine Planning and Design Institute Limited and to the State Government within three months from the close of the half year to which it relates.
- g) The Licensee as well as the Agency shall be responsible for the data furnished in the Geological Report.
- h) The empanelled firm/agency shall obtain Trading License from the concerned Autonomous District Council before the start of the work.
