NOTICE INVITING TENDER

INVITATION FOR TENDER FOR HIRING OF PICK-UP VEHICLE ON A DAILY BASIS FOR REE INVESTIGATION

Sealed tenders are invited from eligible and qualified service providers for the **hiring of pick-up vehicle and Bolero on a daily basis** to support the ongoing Rare Earth Elements (REE) investigation project at the Sung Valley Block, Meghalaya.

Please submit your offers in accordance with the terms and conditions outlined below.

SCOPE OF SERVICE AND REQUIREMENTS

The hired vehicle will be used to transport personnel, equipment, and samples to and from various field sites. The service provider is expected to ensure the availability of the vehicle as per the project's operational needs.

Vehicle Requirements

1. **Type of Vehicle:** Pick-up vehicle and Bolero (4x4)
2. **Condition:** Well-maintained with valid service records.

Hiring Period and Terms

1. **Period:** Daily hire, as and when required, with flexible scheduling.
2. **Locations:** Field sites in Sung Valley Block and nearby areas.
3. **Minimum Availability:** 8 hours per day (extendable based on project needs).

ELIGIBILITY CRITERIA

1. The bidder must provide a **commercial vehicle registration**.
2. The vehicle should have valid **insurance, road permits, fitness Certificate and pollution certificates**.
3. The **driver** must hold a valid license and experience driving in off-road conditions.
4. Preference will be given to bidders with prior experience providing vehicle services for **government projects or mineral exploration activities**.

FINANCIAL QUOTE AND PAYMENT TERMS

1. **Rate per Day:** Bidders must quote a daily rental rate inclusive of all costs (fuel, driver allowance, and maintenance).
2. **Additional Charges:** Specify rates for extra hours beyond the 8-hour daily limit.
3. **Payment Terms:** Payments will be made within **30 days** of receiving the invoice, subject to verification.

EVALUATION CRITERIA

The following criteria will be used for evaluation:

1. Compliance with **vehicle specifications** and service requirements.
2. Competitive **daily rental rates**.
3. Relevant **experience** in providing services for field activities or exploration projects.
4. Availability and flexibility for the project's operational needs.

TERMS AND CONDITIONS

1. The service provider will be responsible for all **maintenance and POL expenses**.
2. The Directorate reserves the right to **terminate the contract** at any time without assigning any reason.
3. In case of **vehicle breakdown**, a replacement vehicle must be provided within 2 hours.
4. The service provider will bear **all liabilities related to accidents or damage of the Vehicle** during operations.
5. All bids must be submitted in **sealed envelopes**, clearly marked with the subject of the tender.

EARNEST MONEY DEPOSIT (EMD)

An earnest money of **Rs 1000/- (one thousand)** in the form of Deposit-at-call or Demand Draft on any branch of State Bank of India, duly pledge in favour of the Directorate of Minerals Resources, Meghalaya, should accompany the tender. In case of Schedule Tribe and Schedule Caste tenderers, the amount of Earnest Money is Rs 500/- (five hundred) only is applicable subject to production of Schedule Tribe/Schedule Caste Certificate. The firm which are registered with A.G.S & D or the Small Scale Industries units registered with NISC form Manufacturing stores to be purchased are exempted from paying Earnest Money.

The **EMD will be forfeited** if the tender is withdrawn or altered during the validity period.

The bidder must submit a **signed declaration** confirming compliance with all the terms and conditions outlined in this document.


